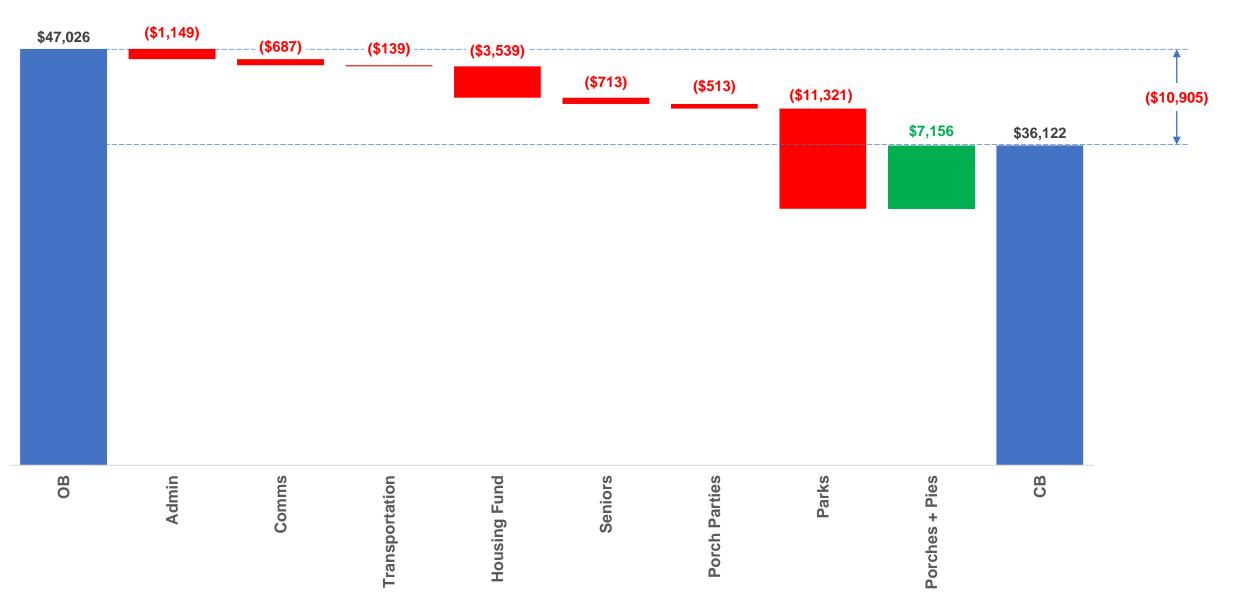

FY23 Highlights

- Adair Park Today is in excellent financial health
 - Opening FY24 with \$36k in the bank
 - FY23 was breakeven (excluding projects)
 - Porches + Pies netted ~\$7k
- Closed out Playground Project; total spend of \$55k+
- Housing Fund paid out over \$8k to neighbors
- \$8.5k raised for major repairs to a long-term neighbor's home
- Continued underspend relative to budget

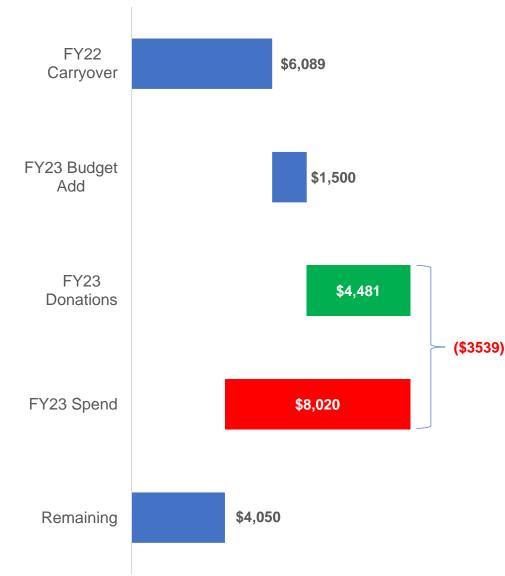

- General Donations in FY22 included \$2k (\$1k per instance) from productions filming in Adair Park
- Some FY22 membership fees were paid ahead of the new year; increase is smaller than shown
- Flag difference is timing; flags sold in FY23 were purchased in FY22
- PO Box expenses for FY23 will be paid in FY24
- Primary 'Other' in FY23 is payment to architect consulting on a non-compliant property
- Website/Email expenses have a plan to reduce
- Storage Unit costs were partially prepaid in FY22; costs have increased by ~20% per month

Housing Fund Summary



- Total Payout of \$8,020 in FY23; \$6,614 in FY22
- 20 awards; average value of ~\$400
- Awards outpaced donations by \$3,539
 - \$4,481 in FY23
 - \$7,426 in FY22
- If we repeat in FY24, the fund will not carry a reserve into FY25
